#### Horizon scanning the legal landscape

This month the Newsletter Committee: Iris Ferber KC (42BR Barristers), Dambu Tenner (Solicitor and Head of Legal, Abri) and Imran Mustak (Solicitor and Legal Manager, L&Q) look at the anticipated impact of the Renters' Rights Bill on the Housing Ombudsman service, what constitutes a "notice" and the use of Alternative Dispute Resolution to resolve disrepair claims.

## **Articles and Legal Updates**

We start 2025 with an article from Justin Bates KC which explores the provisions of the Renters' Rights Bill and how the role of the Housing Ombudsman is likely to be impacted, covering both the PRS and Social Rented Sector. A matter in which the Defendant's legal representatives were deemed not to be entitled to their legal costs as they had not followed the ADR process advised to them.
